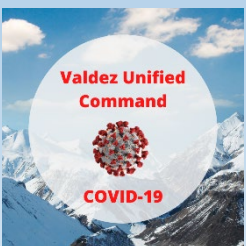

## State of Alaska Case Count



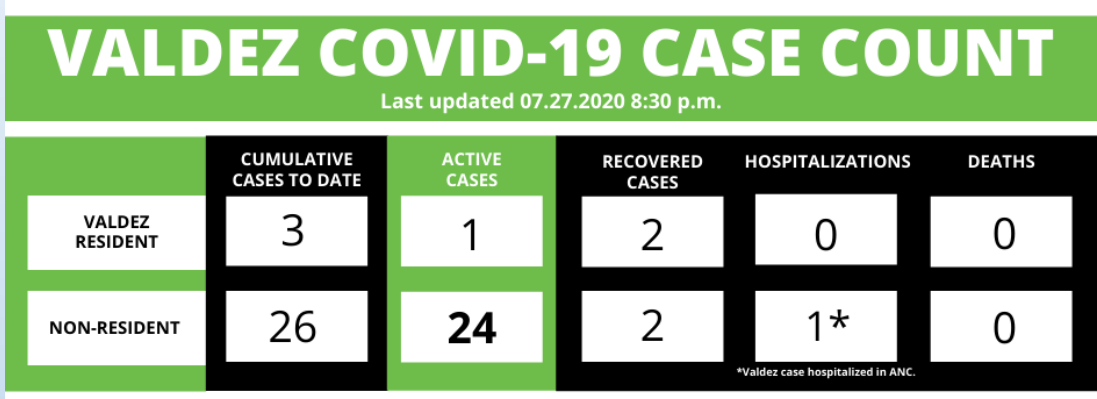
### Active State Mandates

- Mandate 010: International & Interstate Travel
- Mandate 014: Non-Congregate Sheltering
- Mandate 015: Services by Health Care Providers
- Mandate 017: Independent Fishing Vessels
- Mandate 018: Intrastate Travel

**Public Messaging Themes:** Physical distancing. Wearing cloth face coverings around others. Hand and surface hygiene. Keep your bubble small. Avoid gatherings. Bolster resiliency. Understanding of operational processes. Kindness, compassion, & mental health.

**Community Areas of Concerns:** (1) Approaching school year, (2) Economic impacts of COVID-19, (3) testing, (4) influx of visitors and workers, (5) mixed reaction to mask mandate, and (6) impacts of state mandates.

NOTE: Valdez COVID-19 Case Count table is updated in real time. There is often a data delay before our local cases are reflected on the DHSS Response Hub.

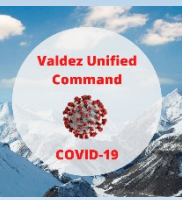
