Required Application Materials:

- **All Applicants:** Proof of current (within last 4 months) electric or fuel bill reflecting the name of the applicant, physical address, and associated active account number. Documents without the required information will not be accepted.
- **Additional Materials Required of Business Applicants Only:** Copy of current City business registration.

Only one credit will be applied per property address, whether it be residence or business. Only one credit per business license, which must be physically located within the city limits of Valdez. For a residence to qualify, there must be an active electric or fuel oil account associated with the property in the name of the individual applying for the credit. Additionally, for a residence to qualify it *must* be the primary residence of the individual applying for the credit. For a locally owned business to qualify, there must be a current City Business Registration and an active electric or fuel oil account associated with property in the name of the business. No other person or business can apply for an energy credit for the same property. In order to be considered for the energy credit this signed registration and all necessary documentation must be **received** by the City **no later than 7:00 p.m. on December 30,**
